The morals of these stories often reinforce the idea that living in accordance with the natural and spiritual laws of the universe leads to a harmonious life, while breaking them leads to suffering or chaos.

Spirit Animals and Nature Spirits

If you behave dishonorably, you will lose your honor. This story teaches children that respect must be earned and maintained through good behavior.

“The Tale of the No-Faced Doll” (Iroquois)

The Iroquois tell a poignant story about a doll who was beloved by the Corn Maiden. The doll was sad because she had no face. She begged the Corn Maiden to give her one. The Corn Maiden warned her that a face would bring both joy and sorrow. The doll insisted, and a beautiful face was given to her. Soon, the doll became vain, spending all her time looking at her reflection in the water. She neglected her duties and her friends. Eventually, the Corn Maiden took the face away. The doll learned that inner beauty and good character are more important than outward appearance. The traditional “No-Faced Doll” (or “Faceless Doll”) is still made by Iroquois artisans to remind children of this very lesson. THE ROLE OF “THE FIRST FIRE” (CHEROKEE AND OTHER TRIBES)

Several tribes, including the Cherokee, tell a version of how fire was brought to the people. In this

story, a great cold covered the earth, and only the animals knew where to find fire. One by one, the brave animals attempted to bring a spark back to the shivering humans. The daring Raven flew first, but his feathers were singed black (explaining why ravens are black). The Screech Owl tried next and got smoke in his eyes (explaining why his eyes are red). Many animals failed. Finally, the tiny Water Spider stepped forward. She spun a small, silky basket, placed a single ember in it, and carried it safely across the water. The moral here is a powerful one: courage and cleverness are not always found in the biggest or strongest. The smallest and most humble creature can succeed where the mighty fail. It is a lesson in humility, resourcefulness, and the value of every member of the community.

WHY THESE LESSONS REMAIN RELEVANT TODAY
