## THE MEANING OF PROVIDE FOR THE COMMON DEFENSE

The phrase "Provide For The Common Defense" appears in the Preamble to the United States Constitution, standing as one of the foundational purposes for which the nation was established. It is a compact statement that carries profound weight, representing the collective commitment of a people to ensure their shared security against external threats and internal vulnerabilities.
