The **Army Weapons Qualification Card**, often referred to as DA Form 3595-R or simply a "qual card," is an official Department of the Army document that records a soldier's qualification scores for individual and crew-served weapons. It serves as a permanent record of a soldier's demonstrated ability to engage targets accurately and safely under prescribed conditions. This card accompanies a soldier throughout their

service, with updates made each time they qualify or re-qualify on a weapon platform such as the M4 carbine, M16 rifle, M9 pistol, M249 squad automatic weapon (SAW), M240 machine gun, and others.

The card typically contains essential data points including the soldier's name, rank, unit, date of qualification, weapon type, range used, firing conditions (day or night, supported or unsupported), and the final score and rating. The rating categories are universally known: Expert, Sharpshooter, and Marksman. Achieving a higher rating can positively impact a soldier's promotion points, assignment opportunities, and professional

reputation.

# Why the Weapons Qualification Card Matters

For the modern soldier, the **Army Weapons Qualification Card** is a critical component of overall readiness. It is not merely a bureaucratic formality. Here are the primary reasons why this card holds such significance:

- **Combat Readiness:** The card is a direct indicator that a soldier can handle and effectively use

Earning an Expert badge and having that reflected on the card is a source

of personal achievement and respect among peers.

## Common Weapons Recorded on the Qualification Card

### While the **Army Weapons Qualification Card**

can accommodate a wide variety of weapon systems, certain firearms are more commonly encountered. The card typically includes blocks for the following:

## INDIVIDUAL WEAPONS

- **M4/M4A1 Carbine:** The standard issue rifle for most soldiers. Qualification on this weapon is mandatory for nearly all personnel.
- **M16 Series Rifle:** Still used in some training environments and by specific units, though being phased out by the M4.
- **M9 and M17/M18 Pistols:** The standard sidearm for officers, military police, and soldiers whose primary duty requires a compact weapon.

- **M249 SAW:** A light machine gun used by automatic riflemen in infantry and support units.

## CREW-SERVED WEAPONS

- **M240B Machine Gun:** A medium machine gun used in ground mounts and vehicle platforms.
- **M2 .50 Caliber Machine Gun:** A heavy machine gun used for anti-materiel and long-range suppression.
- **MK19 Grenade Launcher:** An automatic grenade launcher providing high explosive firepower.

- **Mk 47 Striker:**

An advanced grenade launcher system used by special operations forces.

Each weapon system has its own qualification standards, range cards, and scoring tables. The card captures the specific course used, the total hits, and the corresponding rating.

# How to Read an Army Weapons Qualificat

## ion Card

Understanding the information on the **Army Weapons Qualification Card** is straightforward once you know what each section represents. Although the exact layout may vary slightly depending on the version of the form, most cards contain these key elements:

- **Header Section:**  
Soldier's name, rank, social security number (now masked or replaced by EDIPI), unit, and unit identification code (UIC).
- **Weapon Record Blocks:**  
For each weapon, there is a row or block that includes the

date of  
qualification,  
range name and  
course, condition  
(day/night,  
supported/unsup-  
ported, with or  
without optics),  
total hits/score,  
and the rating  
(Expert,  
Sharpshooter,  
Marksman).

- **Signature and Authentication:** The card must be signed by the soldier and usually by a certifying official (range officer, NCO, or commander).
- **Remarks Section:** Used for notes such as "Initial Qual," "Requal," "Weapon malfunction," or "Fired with iron

sights."

A soldier should verify that all entries are accurate and legible before the card is filed or stored. Any discrepancies should be immediately addressed with the unit's training room personnel.

## The Qualification Process: From Range to Card

Earning a qualification score that appears on the **Army Weapons**

## Qualification Card

involves a structured and rigorous process. It is not simply about shooting; it is about demonstrating safe handling, proper technique, and consistent accuracy under timed conditions.

### 1. **Pre-Range Training:**

Soldiers must complete classroom instruction on weapon safety, malfunction clearing, and proper firing fundamentals. This is followed by dry-fire drills and often a preliminary live-fire practice.

### 2. **Zeroing the Weapon:** Before the record fire, soldiers "zero" their weapon to

ensure the point of aim matches the point of impact at a specified distance (typically 25 meters for the M4).

### 3. **Record Fire:**

The actual qualification event. Soldiers engage targets at varying distances (50 to 300 meters) and in different positions (prone, kneeling, standing). Some courses include moving targets and night fire using night vision devices or infrared lasers.

### 4. **Scoring:** Each hit is recorded. The total score determines the rating. For the



M4, the typical thresholds are:

- Expert:  
36-40 hits  
(out of 40)
- Sharpshooter: 30-35 hits
- Marksman: 23-29 hits
- Unqualified : Below 23 hits

**Completion:**

After the scores are verified, the **Army Weapons Qualification Card** is filled out, signed, and issued to the soldier. The data is also entered into the Army's digital training management systems.

Qualification is not a one-time event. Most weapons require annual re-qualification,

though some units may require more frequent training. Soldiers who deploy or are assigned to combat roles may need to qualify before and after deployment.

## Maintaining and Safeguarding Your Qualification Card

The **Army Weapons Qualification Card** is a valuable document that should be treated with care. Losing it can cause administrative headaches, especially if a deployment or promotion board is imminent. Here are

some best practices for maintaining your card:

- **Keep it in a secure place:** Many soldiers carry their card in their ID card holder or in a sealed, waterproof pouch along with their Common Access Card (CAC). Avoid folding or laminating it if possible, as some range facilities require the original card for updates.
- **Make a digital copy:** Scan or take a high-resolution photo of the card and store it in a secure digital location, such as an encrypted email or a personal cloud drive with multi-

factor authentication.

- **Check for errors:** After each qualification, review the entries for misspellings, incorrect weapon models, or wrong dates. An error can affect your official record.
- **Report loss immediately:** If the card is lost, report it to your unit's training NCO. A replacement can be generated from the digital record, but it requires time and administrative action.

# Common Challenges and Misconceptions

- **Misconception: "Qualification only matters for infantry."** In reality, most military occupational specialties (MOS) require annual qualification on a primary weapon.

current qualification card that is updated over time. If you have multiple cards, consolidate them through your training room to ensure the most recent records are accurate.

- **Misconception: "A night fire qualification is separate from day qualification."**

While night fire is a separate event, the qualification card often includes a line for night qualification under the same weapon system. Some units require both day and night qualification for full readiness

status.

## Digital Transition and the Future of Qualification Records

While the physical **Army Weapons Qualification Card** remains in widespread use, the Army is progressively moving toward digital training records. Systems like the Digital Training Management System (DTMS) and the Army Training Information System (ATIS) now store qualification data

electronically. This means that even if a soldier loses their physical card, the official record can be retrieved and a new card issued.

However, the physical card is still required for many field exercises, range operations, and unit-level inspections. The dual system—paper and digital—ensures redundancy and accountability. Digital systems can automatically validate scores, reduce human error in transcribing numbers, and provide commanders with real-time snapshots of unit

marksmanship readiness.
