As demand soared, Ford needed a larger, more efficient facility. The answer was the massive River Rouge Complex in Dearborn, Michigan, which opened in the 1920s. The Rouge was not just a factory; it was a self-contained industrial city. The Ford Motor Company history entered a phase of extreme vertical integration. Raw materials like iron ore and coal entered at one end, and finished automobiles rolled out

the other. The complex had its own steel mill, glass factory, and power plant.
