## Step 1: Prepare for Administ ration

Before testing, review the manual's administration guidelines thoroughly. Note the standardized prompts, acceptable cues, and discontinue rules. The manual emphasizes that deviations from the standardized protocol invalidate the normative comparison. Gather the stimulus book, record form, and scoring manual. Ensure

you have a quiet environment with good lighting so that both you and the examinee can see the pictures clearly.

## Step 2: Administer and Record Responses

During administration, record the examinee's responses directly on the record form. The **GFTA-3 Scoring Manual** includes a key that shows which phonemes are being evaluated for each item. Use the manual's phonetic transcription

# Standard Scores and Confidence Intervals

## COMMON SCORING CHALLENGES AND HOW TO AVOID THEM

# S

Age equivalents are provided in the manual but are often misunderstood. The **GFTA-3 Scoring Manual** explicitly warns against using age equivalents as eligibility criteria or as indicators of "speech age." They represent the median raw score for a given age group, not the expected performance level. For example, a 7-year-old with an age equivalent of 5;6 has a raw score similar to the average 5-and-a-half-year-old, but this does not mean the child "speaks like a 5-year-old." Always prioritize standard scores and percentile

## Distinguishing Errors from Dialectal Variation

# S

One of the most challenging aspects of using the **GFTA-3 Scoring Manual** is differentiating a true articulation error from a dialectal or accent-related variation. The

manual provides specific guidance for African American English, Spanish-influenced English, and other linguistic varieties. For instance, the production of "dis" for "this" in African American English is dialectally appropriate and should not be scored as an error. Failure to account for dialectal variation leads to inflated error counts and misdiagnosis. The manual encourages clinicians to consult dialectal resources and to consider the child's language background before scoring.

## s and Lisps

Dentalized, lateralized, or palatalized productions can be difficult to score consistently. The **GFTA-3 Scoring Manual** classifies distortions as errors, though some borderline cases require careful listening. If a child produces /s/ with mild dentalization, is that a distortion or a correct production? The manual states that any production that deviates from the standard phoneme in a way that is noticeable to a listener should be scored as incorrect. Consistency within and across clinicians strengthens the validity of your findings.

# Handling Self- Corrections and Articulatory Groping

Children sometimes self-correct during the response. The manual instructs clinicians to score the final production. However, if the child gropes or produces multiple attempts, score only the last complete

attempt. If the child cannot produce a target sound at all and the response is incomplete, follow the manual's guidelines for omitted or unscorable responses. These nuances are detailed in the **GFTA-3 Scoring Manual** and should be reviewed periodically, especially for clinicians who administer the test infrequently.
