## Education al Background nd

A high school diploma or GED is the minimum educational requirement for most police departments. However, many agencies strongly prefer candidates who have completed some college coursework or hold an associate's or bachelor's degree.

Criminal justice, sociology, psychology, and public administration are common fields of study that provide relevant knowledge. A college education can set you apart from other applicants and may lead to faster promotion opportunities later in your career. Some departments also offer tuition reimbursement programs to encourage ongoing education.

## Driving Record and Criminal

## History

A valid driver's license and a clean driving record are essential. Most departments require a history of responsible driving without major violations such as DUL or reckless driving. Additionally, candidates must have a clean criminal record. Misdemeanor offenses, especially those involving dishonesty or violence, can disqualify you. Felony convictions are an automatic disqualification for all law enforcement positions. Background checks are thorough, and any history of drug abuse or domestic violence can also eliminate you from consideration.

## Physical and Medical Standards

Police work is physically demanding, so candidates must meet specific fitness standards. Most departments administer a physical agility test that includes running, push-ups, sit-ups, and obstacle course challenges.
