Mechanics: The Starting Point

Hamiltonian mechanics goes further by replacing velocities with momenta and using a set of first-order equations instead of second-order ones. Hamilton's equations are symmetric in time and provide deep insights into conservation laws, phase space, and integrability. For particles, both Lagrangian and Hamiltonian approaches reveal symmetries via

Noether's theorem: to every continuous symmetry corresponds a conserved quantity. For instance, spatial translation invariance leads to conservation of linear momentum; time invariance leads to conservation of energy.

where ρ is density and $\mathbf{v}$ is velocity. The balance of linear momentum yields Cauchy's equation of motion:

$$\rho D\mathbf{v}/Dt = \nabla \cdot \boldsymbol{\sigma} + \rho \mathbf{b}$$

Here $\boldsymbol{\sigma}$ is the Cauchy stress tensor and $\mathbf{b}$ is the body force per unit mass (e.g., gravity). This equation is the continuum analogue of Newton's second law. For equilibrium (static or dynamic), we set the left side accordingly.

Similarly, the balance of angular momentum implies that the stress tensor is symmetric ($\boldsymbol{\sigma} = \boldsymbol{\sigma}^T$), in the absence of body couples.

Energy conservation gives the first law of thermodynamics applied to a continuum, which couples mechanical and thermal effects. These balance laws, together with constitutive equations, form a closed system of partial differential equations for the fields of interest.

KEY SUBFIELDS OF CONTINUUM MECHANICS

Linear Elasticity

Linear elasticity describes solids that

deform reversibly under small strains. The constitutive relation is Hooke's law: stress is linearly proportional to strain via the fourth-order elasticity tensor (for anisotropic materials) or two independent constants for isotropic materials: Young's modulus and Poisson's ratio. The equations of linear elasticity are widely used in structural analysis, geomechanics, and biomechanics.

Solutions to elasticity problems often involve methods like the Airy stress function, complex potentials, or finite element analysis (FEM). Theoretical results—such as Saint-Venant's principle, stress concentrations around holes, and wave propagation in elastic media—are

foundational for engineering design.

Fluid Dynamics

The mechanics of fluids (liquids and gases) is another pillar of continuum theory. The Navier-Stokes equations for viscous fluids combine the momentum balance with a constitutive relation for a Newtonian fluid, where viscous stress is proportional to the rate-of-strain tensor. These nonlinear partial differential equations are notoriously difficult to solve analytically, yet they govern phenomena from laminar pipe flow to turbulent eddies.

Inviscid flows (Euler equations) simplify

analysis but still capture crucial features like lift, drag, and wave motion. Bernoulli's principle, a consequence of energy conservation along streamlines for steady, inviscid flow, is a classic result taught in introductory physics. For compressible flows, such as high-speed aerodynamics, additional equations for density and pressure close the system.

Viscoelasticity and Plasticity

Many real materials exhibit time-dependent or irreversible behavior. Viscoelastic models combine elastic and viscous responses,

capturing creep and relaxation observed in polymers, biological tissues, and geological formations. Plasticity theory deals with permanent deformation beyond a yield point; the mathematical framework involves yield surfaces, flow rules, and hardening laws.
