A question about a client with borderline personality disorder, for example, might have multiple plausible-sounding interventions. Understanding why "set firm, consistent limits" is superior to "allow the client to set their own schedule" requires a deep understanding of the disorder's dynamics.

## Simulating Clinical Reality

When studying specific disorders, use the test bank to visualize the client. For example, when reviewing a set of questions on major depressive disorder, pause to imagine a client with psychomotor retardation, anhedonia, and suicidal ideation. What would your first assessment question be? How would you prioritize your interventions? This mental simulation bridges the gap between textbook theory and clinical practice.

## STUDENTS
