## THE CORE COMPONENTS OF AN ABG REPORT

## pH (Hydrogen Ion Concentration)

The pH indicates whether the blood is acidic, alkaline, or neutral. A normal arterial pH ranges from 7.35 to 7.45. Values below 7.35 indicate acidosis, while values above 7.45 indicate alkalosis. The

body works hard to maintain pH within this narrow range because even small deviations can impair enzyme function and cellular activities.

## PaCO<sub>2</sub> (Partial Pressure of Carbon Dioxide)

PaCO<sub>2</sub> reflects the respiratory component of acid-base balance. Normal values are 35 to 45 mmHg. Carbon dioxide is acidic in nature, so a high PaCO<sub>2</sub> (hypercapnia) suggests respiratory acidosis, while a low PaCO<sub>2</sub> (hypocapnia) suggests respiratory alkalosis. ## PaO<sub>2</sub> (Partial Pressure of Oxygen)

PaO<sub>2</sub> measures the amount of oxygen dissolved in the arterial blood. Normal values range from 80 to 100 mmHg. Values below 80 mmHg indicate hypoxemia, which can result from various conditions such as lung disease, heart failure, or anemia. PaO<sub>2</sub> is critical for assessing oxygenation status.

## HCO<sub>3</sub> (Bicarbonate)

Bicarbonate is the metabolic component of acid-base regulation. Normal values are 22 to 26 mEq/L. The kidneys control bicarbonate levels, which act as a buffer against pH changes. Low bicarbonate suggests metabolic acidosis, while high bicarbonate suggests metabolic alkalosis.

## Base Excess (BE)

Base excess is a calculated value that indicates the amount of buffer base in the blood. Normal BE ranges from -2 to +2 mEq/L. A negative base excess indicates a base deficit, which is typically seen in metabolic acidosis. A positive base excess indicates metabolic alkalosis. This value helps confirm the metabolic component of an acid-base disorder.

## Oxygen Saturation (SaO<sub>2</sub>)

SaO<sub>2</sub> represents the percentage of hemoglobin saturated with oxygen. Normal values are 95 to 100 percent. While pulse oximetry provides a non-invasive estimate, ABG gives a precise measurement. SaO<sub>2</sub> is closely related to PaO<sub>2</sub> but is influenced by the oxygen-hemoglobin dissociation curve.

## Step 1: Assess the pH

This step identifies whether the primary problem is respiratory or metabolic.

- Respiratory acidosis: low pH and high PaCO<sub>2</sub>
- Respiratory alkalosis: high pH and low PaCO<sub>2</sub>
- Metabolic acidosis: low pH and low HCO<sub>3</sub>
- Metabolic alkalosis: high pH and high HCO<sub>3</sub>

## Step 3: Check for Compensation

The body attempts to counteract acid-base disturbances through compensation. Respiratory compensation occurs within minutes, while renal compensation takes hours to days. In a compensated disorder, the pH may be normal or near normal because the opposite system has adjusted. For example, in chronic respiratory acidosis, the kidneys retain bicarbonate to bring the pH back toward normal. The level of compensation helps you determine whether the disorder is acute or chronic.

## Step 4: Evaluate Oxygenation

Separate from the acid-base analysis, assess the PaO<sub>2</sub> and SaO<sub>2</sub> to determine the patient's oxygenation status. Hypoxemia is defined as PaO<sub>2</sub> below 80 mmHg while breathing room air. The PaO<sub>2</sub> can be interpreted in the context of the fraction of inspired oxygen (FiO<sub>2</sub>) using the PaO<sub>2</sub>/FiO<sub>2</sub> ratio. A ratio below 300 suggests mild acute lung injury, while a ratio below 200 indicates severe hypoxemia consistent with acute respiratory distress syndrome.

## Step 5: Look for Mixed Disorders

Sometimes more than one acid-base disorder is present simultaneously. For instance, a patient with sepsis may have metabolic acidosis from lactic acidosis and respiratory alkalosis from hyperventilation. Recognizing mixed disorders requires careful attention to whether the pH, PaCO<sub>2</sub>, and HCO<sub>3</sub> are moving in the same direction or opposite directions. When the primary disturbance and compensation do not match expected patterns, suspect a mixed disorder.

### COMMON ACID-BASE DISORDERS EXPLAINED

## Respiratory Acidosis

## Metabolic Acidosis

Metabolic acidosis occurs when the body produces excess acid or loses bicarbonate. It is divided into two main types: high anion gap and normal anion gap. Common causes of high anion gap metabolic acidosis include diabetic ketoacidosis, lactic acidosis, renal failure, and toxic ingestions. Normal anion gap metabolic acidosis is often due to diarrhea or renal tubular acidosis. The ABG shows low pH and low HCO<sub>3</sub>. ## Metabolic Alkalosis

Metabolic alkalosis results from excess bicarbonate or loss of acid. Causes include vomiting, diuretic therapy, mineralocorticoid excess, and alkali ingestion. The ABG shows high pH and high HCO<sub>3</sub>. Respiratory compensation is limited because hypoventilation to raise PaCO<sub>2</sub> is counteracted by hypoxia.

6. **Use the Winters formula for metabolic acidosis.** The expected respiratory compensation for metabolic acidosis is  $\text{PaCO}_2$  equals 1.5 times  $\text{HCO}_3$  plus 8, plus or minus 2. If the measured  $\text{PaCO}_2$  is within this range, compensation is appropriate. If it is lower or higher, suspect a mixed disorder.

### COMMON PITFALLS TO AVOID
