Comparative Perspectives

CANADA

Canada follows a decentralized model similar to the U.S. but with a unique feature: the **Section 33 notwithstanding clause**, which allows provincial or federal legislatures to override certain court rulings for a renewable five-year period. This mechanism balances judicial review with democratic accountability. The Supreme Court of Canada has used judicial review to advance indigenous rights, language rights, and fundamental freedoms.

INDIA

India has one of the most robust systems of judicial review, grounded in the Constitution of 1950. The Supreme Court of India can invalidate both parliamentary laws and executive orders that violate fundamental rights or the basic structure of the Constitution. The "basic structure doctrine" was developed in the famous *Kesavananda Bharati* case (1973) to prevent the legislature from destroying the Constitution's essential features through amendments. This demonstrates that the answer to **what is a judicial review** can evolve dynamically over time.
